## **DEVELOP OF THE ASSEMBLY:**

# **1.-** Constitution of the bureau and Approval of the minutes of the previous Extraordinary Assembly

The General Assembly begins with the **constitution of the bureau**. The following members of the Board of the Directors are present in the room and access to the presidential table: Aida Carvalho (Vicepresident), Leoncio Carrascal (Secretary) and Olga Moreno (in representation of the Treasurer).

Mr Germinal Peiro, president, attends by ZOOM connexion.

The session is opened by a short speech from the president Mr Peiro giving thanks to everyone for the attendance.

2.- The **minutes of the previous Extraordinary Assembly**, held in Côa Museum (Vilanova de Foz Côa, Portugal) on December 1<sup>st</sup> 2023, are introduced and approved unanimously.

3.- Updating of the list of members of the association (new members and resignations)
It is reported that the following institutions have left the Association:
-ADECOCIR (Castilla y León, Spain)
-CENTRO CAMUNO STUDI PREISTORICI (Italy)
-REDONDELA TOWN COUNCIL (Galicia, Spain)

The first two have done so in writing and have paid all their outstanding dues. On the other hand, the Town Council of Redondela has done so by telephone (it has not been possible to obtain a written document, despite repeated requests, and they owe the dues from 2019 to 2023, i.e. 5 dues of 650 euros -total: 3,250.00 euros-).

### 3.- Actualización del listado de socios de la asociación (altas y bajas)

Se informa que han causado baja en la Asociación, las siguientes instituciones: -ADECOCIR (Castilla y León, España) -CENTRO CAMUNO STUDI PREISTORICI (Italia)

-AYUNTAMIENTO DE REDONDELA (Galicia, España)

Los dos primeros lo han realizado por escrito y abonando todas sus cuotas. Por el contrario, el Ayuntamiento de Redondela lo ha hecho por teléfono (no ha sido posible obtener un documento por escrito, pese a que se ha pedido reiteradamente, y adeudan las cuotas de 2019 a 2023, es decir, 5 cuotas de 650 euros -total: 3.250,00 euros-)

NEW ACCESSIONS:

- ARREDONDO TOWN COUNCIL (Cantabria, Spain)

- PROVINCIAL COUNCIL OF GIPUZKOA (Basque Country, Spain)



The accession of these two new members is approved, after completing the administrative process.

They will be officially presented at the General Assembly in Murcia in November.

Besides, the following entities are currently in the process of accession:

CAMINHA MUNICIPAL CHAMBER OF CAMINHA (Portugal)
MUSEUM OF ARCHAEOLOGY OF PULA (Croatia)

In addition, the following have expressed their interest in joining: City Council of Cieza (Murcia), City Council of Fuencaliente (Ciudad Real, Castilla La Mancha).

### 4.- Approval of the change of fiscal address of the CARP Association.

Fernando Isasi, manager of CARP and the Cantabrian Network for Rural Development (RCDR) explains that there is a legal problem (warned by the legal services of the RCDR): both associations share the same fiscal address, located at: C/ Luis Riera Vega, 2 - 39012 SANTANDER.

Given the technical, legal and economic relations between both entities, it is advisable to change the tax domicile to one of the entities, to avoid possible tax inspections and misunderstandings.

Leoncio Carrascal, secretary of CARP and mayor of the Municipality of Arredondo, has offered an empty office in the building where his town hall is located, to house CARP's fiscal headquarters: **C/ Gutiérrez Solana, 2 - Local 1 - 39813 ARREDONDO (Cantabria, Spain).** 

The proposal was adopted unanimously.

5.- Proposal for the incorporation of the PRAT Association to the association of associations 'Cultural Routes in Spain', with payment by the Spanish members only of an annual contribution of 300 euros per Spanish partner.

The history of PRAT's participation in the 'tourism brand' of TURESPAÑA 'Cultural Routes in Spain' , <u>https://www.spain.info/en/top/cultural-routes-in-spain/</u> is reviewed, which, since 2023, has become a Tourism Product Club of the Secretary of State for Tourism of the Ministry of Industry and Tourism of the Government of Spain, with the legal constitution of the Association of the same name (RCE) <u>https://www.spainculturalroutes.com/</u>.

President Germinal Peiro explains the position of the Board of Directors, in favour of Spanish members working in this Tourist Product Club, but constituting a Spanish association for this



purpose, or delegating in a Spanish member for the representation of all of them to represent them in it.

He explained the case of France, where the Conseil Departemental de La Dordogne has become a member of the Federation Française de Itinéraires Culturels de France <a href="https://www.ffice.fr/">https://www.ffice.fr/</a>, where it works to ensure that the Rock Art of France represented in PRAT participates in its activities.

The president states that the PRAT logo and brand can be used in this Spanish Tourism Product Club (Rutas Culturales de España), but that it would be better that, given the European character of PRAT Association (as the managing entity of a Cultural Route of the Council of Europe), PRAT is not legally incorporated in the new association of Cultural Routes in Spain.

Ana Manrique (representative of Valles Pasiegos Association) argued that PRAT should be able to join national associations of cultural routes in Spain and other countries. She explained the difficulty of creating a new association of Spanish entities to join CRS and the complexity of one member being able to represent all the others in CRS. She argues that the CRS association has received a project from the "Tourism Experiences Spain" programme (like the one received by CARP -Art-Points), of which PRAT is also a beneficiary.

Several interventions followed, explaining several questions and/or positioning the different partners on the issue: Fernando Isasi, Valérie Chamouton and Ramón Montes clarify several technical questions so that partners can have all the information; Pilar Fatás (Museo de Altamira) proposed a 'bridge' solution for two years, Hipólito Collado (Junta Extremadura) proposed a vote, once it has been verified that it is legally possible for PRAT Association to join another association, Teresa García (Ayuntamiento Calasparra) and German Romanos (Asociación Oriente de Asturias) defended membership, Juan Antonio López (Comunitat Valenciana) and José Antonio Andrés (Government of Aragón) insist on the difficulty of creating a 'Spanish' association parallel to PRAT Association and state that non-Spanish members will not be harmed, Aida Carvalho (Côa Parque Foundation) asks once again that a Spanish association must be created and Ana Manrique reiterates the difficulty of this solution, Arturo Pérez (Junta Andalucía) justifies that, despite the interest of the proposal, there are entities that do not support it...

Finally, a vote was taken by show of hands, and the result was as follows:

### Proposal to be approved:

The PRAT Association is incorporated as a full member of the Association of associations 'Cultural Routes in Spain', with payment by all Spanish members of an annual contribution of 300 euros. Members from other countries are exempt from this payment, of course.

Votes cast: 26 (there are members who do not participate in the voting, as their official representative does not participate and does not have a proxy vote).

Votes in favour: 18 Votes against: 4 Abstentions: 4

Given that article 19 of the CARP Association Statutes states that:

ARTICLE 19 – The agreements will be taken by a simple majority of votes present or represented. To reach agreements on the separation of members, election of the Committee, modification of the Statutes, admission of new members, constitution of a Federation of associations or entry in a Federation that already exists, it will be necessary for the agreement to be accepted by a qualified majority of two-thirds of the votes present or represented. In the case of the dissolution of the Association, the procedure in Article 46 of the present statutes will be followed.

#### Therefore, 66.6% of the votes cast are required to approve the proposal.

As 69.23% of the votes cast were cast, the proposal was adopted.

### 6. Requests and questions

There were none.

There being no further business, the meeting was adjourned at 17:45.
